

General Terms and Conditions Aldapt

1. Definitions

1.1. **Aldapt**: trade name of BS Adventure, located at Houtekietstraat 31, 8540 Deerlijk, Belgium, registered with the KBO under number BE0764 372 668, hereinafter referred to as "we", "us" or "Aldapt".

1.2. **Client**: the natural person or legal entity entering into an agreement with Aldapt.

1.3. **Services**: Al implementation, digital transformation, and related consultancy services.

2. Applicability

2.1. These general terms and conditions apply to all quotations, agreements, and services of Aldapt.

2.2. Deviations from these conditions are only valid if agreed upon in writing.

3. Quotations and Agreements

- 3.1. All quotations are non-binding and valid for 30 days unless stated otherwise.
- 3.2. An agreement is established after written confirmation by both parties.

4. Execution of Services

- 4.1. Aldapt will perform the services to the best of its knowledge and ability.
- 4.2. The client ensures timely provision of required information and access to systems.

5. Rates and Payment

- 5.1. Rates are exclusive of VAT unless stated otherwise.
- 5.2. Payment must be made within 30 days after the invoice date.
- 5.3. Statutory interest is due in case of late payment.



6. Intellectual Property

- 6.1. All intellectual property rights remain with Aldapt unless agreed otherwise.
- 6.2. The client receives a right of use for the delivered services and products.

7. Confidentiality

- 7.1. Both parties are obliged to maintain confidentiality of confidential information.
- 7.2. Aldapt will only use client data for the agreed services.

8. Liability

- 8.1. Aldapt's liability is limited to the invoice amount of the relevant assignment.
- 8.2. Aldapt is not liable for indirect damage.

9. Duration and Termination

- 9.1. Agreements are entered into for the agreed period.
- 9.2. Termination must be done in writing with a notice period of 30 days.

10. Privacy and Data Protection

- 10.1. Aldapt processes personal data in accordance with GDPR/AVG.

- 11.2. Changes will be announced 30 days in advance.
